Introduction to Module 5

- Why was this module developed?
 - It is important for primary care practices (including RHCs) to engage in quality related activities in today's environment
 - New initiatives incentivize providers through public reporting or financial reward to demonstrate performance
 - National Quality Forum Report commissioned by HHS & released in 2015 recommends mandatory quality measurement programs for rural providers
 - This module serves as a guide to assist SORHs in providing technical assistance to RHCs in performance measurement & quality improvement

Current Requirements

- RHC Conditions of Participation (Appendix G of Medicare State Operations Manual)
- The survey process & deeming entities
- Current CMS Quality Requirements
 - Program Evaluation
 - Determines if utilization of services is appropriate
 - Determines if policies & procedures are being followed
 - Recommends any necessary changes
 - Requires a written “Program Evaluation Plan”
 - Requires a “Program Evaluation Committee” or “Professional Advisory Group” to carry out the program evaluation



CMS Proposed QAPI Rule

- Initially proposed by CMS in February 2000 to replace annual program evaluation with a more comprehensive QAPI (Quality Assessment and Performance Improvement) program
- Final rule issued in December 2003
- Due to technicalities related to issuance of proposed rules, the final rule was withdrawn by CMS in September 2006
- CMS has indicated the intention to reissue a new proposed rule
- RHCs may voluntarily implement a QAPI program as outlined in the final rule



The Changing Environment

In an effort to create a high quality healthcare system in the US, payers, providers, government agencies, and delivery systems are developing quality initiatives to improve primary care practice performance. Examples described in the module include:

- Accountable Care Organizations
- Chronic Care Management Reimbursement
- Hospital Outpatient Quality Reporting (OQR) Program
- Medicare Access & CHIP Reauthorization Act of 2015 (MACRA)
- Medicare and Medicaid EHR Incentive “Meaningful Use” Program
- Patient Centered Medical Home
- Physician Compare and the Physician Quality Reporting System (PQRS)
- Value Based Payment Modifier Program



National RHC Quality Project

- FORHP convened key stakeholders to develop a core set of proposed RHC quality measures
- Project Goals:
 - Identify core quality measures actionable and feasible for RHCs
 - Pilot test, evaluate and refine the measures
- The pilot project is a vehicle to:
 - Gain access to quality reporting tools
 - Engage a cadre of like-minded RHCs to benchmark performance and learn from one another
 - Influence and shape measures to monitor RHC quality performance
 - Document and improve clinical performance

- Develop toolkit for sample Program Evaluation resources
- Direct RHCs to experts
- Provide education and training
- Compile & distribute FAQs
- Share best practices
- Start an RHC Quality Network
- Train staff in performance measurement and quality improvement
- Reach out to state survey agency to understand expectations/process
- Develop relationships with deeming entities
- Proactively engage in learning about national initiatives
- Track and share the progress of the RHC Quality Project
