

assist in the development of an integrated health care network, specifically for entities that do not have a history of formal collaborative efforts.


The program will support 1 year of planning with the primary goal of helping networks **create a foundation** for their infrastructure and focusing member efforts to address important regional or local community health needs.

How long has your network been in existence?








2016 Network Planning Grantees:

Personal Level of Experience with Network Development?







Rural Health Opioid Program (RHOP)— to promote rural health care services outreach by expanding the delivery of opioid related health care services to rural communities.

- Vision: Women in rural Arizona will experience optimal health and wellness.
- Mission: The Arizona Rural Women's Health Network's mission is to build our partners' capacity to cultivate and promote innovative policies, practices, and services that improve the health of women in rural Arizona.



White Pine County Hospital District *Ely, Nevada*

Rural Health Network Development (RHND) Program -- to support mature, integrated rural health care networks that have combined the functions of the entities participating in the network in order to address the health care needs of the targeted rural community.

- The network will implement a financial strategy that will reduce costs, improve quality and delivery of health care services, and improve medical oversight.
- Improve the quality and safety of health care by improving care transitions from the hospital to other settings and reducing hospital readmissions.
- Improve coordination of services. Integrating emergency medical services (EMS) in hospital settings.



Stigler Health and Wellness Center, Inc. Stigler, Oklahoma
