Vulnerable Rural Hospital Assistance Program

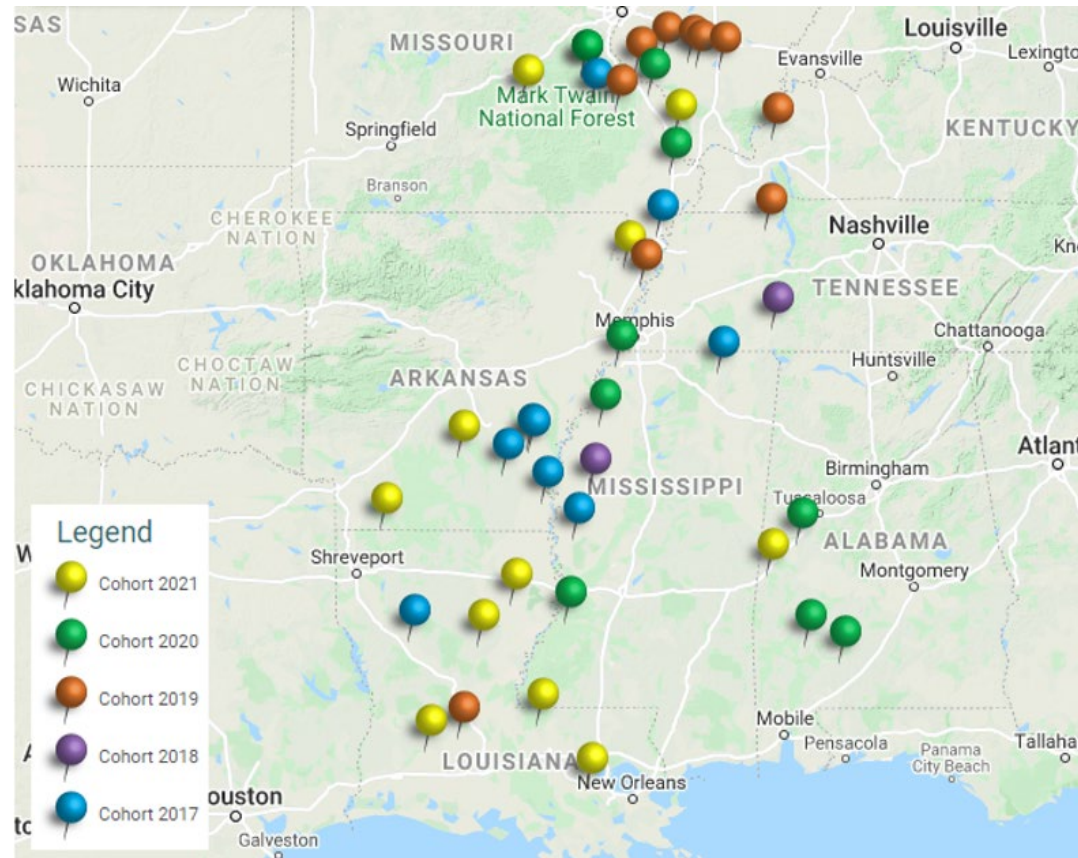
- [Provides](#) targeted assistance to hospitals working to maintain health care services.
