

## June 2023 Gathering of the RHCRC

#### Goal

To work together to develop a shared action agenda with steps that can be taken

to build partnerships, programs, and policies

that will increase pre-development support and flow of capital

to address critical healthcare needs and the conditions

that drive health and well-being in rural America.



## Themes and Ideas

- Building ecosystems at the community and regional level that support the ability to absorb capital
- Place making: Helping rural leaders create vibrant communities
- Community readiness: Build capacity at the local level
- Scaling successful models of rural health and community/rural development partnerships



## Approach

Scaling local innovation should inform programs
that are less top-down, prescriptive, and siloed.
We should not make rural health solutions
fit into narrowly defined requirements and restrictions,
but should support innovation, experimentation and
learning.



## **Ideas for Actions**

- Spread knowledge and evaluation of model federal programs such as USDA Rural Partners Network, the SBA hosted state meetings on federal resources, and the EDA Recompete Program
- Develop a plan to scale up successful models, such as West Virginia Rural Health Development and Invest Appalachia to other states and regions
- Build on the successes of thought leader organizations and their work through partnerships and engagement with the rural health community



## **Ideas for Actions**

- Develop multi-sector RHCRC teams to jointly communicate these strategies
- Work with RHIhub and USDA Economic Research Service to expand information and research on rural health capital resource investments and multi-sector partnerships
- Provide technical assistance to State Offices of Rural Health on developing state level Rural Health Capital Resources Councils
- Expand work with philanthropy on rural health capital resources ideas
- Develop an information network to increase understanding of how to access and blend financial and other resources for rural community well-being
